# 2019-2020 Annual Membership Meeting

On Tuesday, July 16, the Shelby County Chamber of Commerce & Industry held its annual membership meeting for 2019-2020 at the C.G. Therkildsen Center in Harlan.

The following are the 2019 – 2020 Shelby County Chamber of Commerce & Industry's Board of Directors: Josh Grimes, President; Ellen Walsh-Rosmann, Vice President; Gervas Mgonja, Treasurer; Steve Kenkel, Past President; Steve Ineson, Board Member; Doug Schmitz, Board Member; Sheri Tyrrel, Board Member; and Connie Wees, Board Member.

The Chamber staff presented the 2019-2020 fiscal year review for the Shelby County Chamber of Commerce & Industry.

FY19 Accomplishments: Economic Development.

- Housing: Prairie Fire to develop 38 townhomes in the Dye Street complex.
- \$100,000 Catalyst Grant awarded to a local business owner for Downtown District building renovation.
- Completion of Hansen House Memory Care facility and the Harlan Plaza project.
- Growth Assistance Plan (GAP) Loans. Working with SWIPCO, a local business received a \$100,000 Growth Assistance Loan.
- Business Start Ups. Worked in conjunction with the Iowa Small Business Development Center's Council Bluffs office to support two new business start-ups in the area.
- Federal and State Legislative Efforts. Hosted multiple federal and state representatives, including Senator Joni Ernst, Governor Kim Reynolds, and Congressman Steve King. Hosted public forums for multiple state and federal candidates during last election.

FY19 Accomplishments: Shelby County Chamber of Commerce & Industry.

- Membership Growth. We added twelve new members to the Chamber in the past fiscal year.
- Revenue Growth. Total revenue in FY19 grew to \$206,317 15% growth over FY18.
- Website. There were 267,299 Member Views through the website in FY19. There were 14,936 Traffic Catcher Site views in FY19. TCS Page View increased 11.5% over FY18.

Social Media Update – our Facebook and Twitter Accounts.

- Facebook.
  - Performance. "Likes". Increased from 609 in FY18 to 773 in FY19.
  - Reach, The number of people who had our page's posts on their screen. Increased from 372 in FY18 to 450 in FY19 per day. This is a 21% increase.
  - Post Engagement. The number of times people have engaged in our posts through likes, comments, and shares and more. Peaks in early evening hours.
- Twitter.
  - Currently, we have 175 people following our Twitter page and 202 actual followers.

- Opportunity Zone. Created by the Tax Cuts and Jobs Act of 2017. Allows for certain capital gains investment and tax savings.
- Refurbish and renovate existing stock.
- Workforce Housing.

- Retail recruitment.
- "Placemaking" efforts. Capitalize on our local assets, inspirations, and potential, with the intention of creating public spaces that promote people's health, happiness, and well-being.
- Regional Economic Development Plan.
